8. **Library Director's Report** - Martha Nork for Laura Mancini
 - Carla Eggert, the NDL's Business Operations Specialist, will be retiring on July 26th. Carla has been with the NDL since 2012 and will be greatly missed.
 - Summer Reading 2024 has begun and this year's theme is *Adventure Begins at Your Library*. Individuals of all ages can register for the program using the Beanstack app which can be downloaded from the app store or accessed on the Library's website. Paper reading logs are also available at the Information Desk. The program kicked off with a bang as 374 people registered for the program during its first week.
 - The Youth Department will be hosting Touch a Truck on Saturday, June 22nd at Northville High School from 10 a.m. to 12:00 p.m. Trucks of all shapes and sizes will be on hand for young people to explore.
 - From June 17 - August 3, the NDL is hosting a school supplies drive to benefit Cooke School. A list of supplies needed by the school is available in the Youth Department.

9. **Treasurer's Report** - Linda Schwelnus

The Treasurer presented the Financial Report for May 2024. Income included dividends on the CD that matured, Bank Interest, Donations, Membership and Used Book sales, including vendor sales, for a total of \$8,136.04. Expenses included annual meeting expenses for snacks, fees for FOML meeting, newsletter, and snacks for the Staff, for a total of \$274.

A new 13-month CD was purchased with funds from the matured CD. Bank balances, including two CD's, totaled \$76,234.70 at the end of May.

A motion to approve the Financial Report for May 2024, was made by Claire Kreher and seconded by Kathy Fox. It was unanimously approved.
